## Alarming Euthanasia Statistics

The latest statistics released this summer on euthanasia and assisted suicide in Canada reveal that the alarming rate of lethal injections continues. From 2016 when assisted death (MAID) was legalized in Canada, to December 31, 2021, over 31,000 Canadians have been put to death. The *Third Annual Report on Medical Assistance in Dying in Canada 2021* reported:

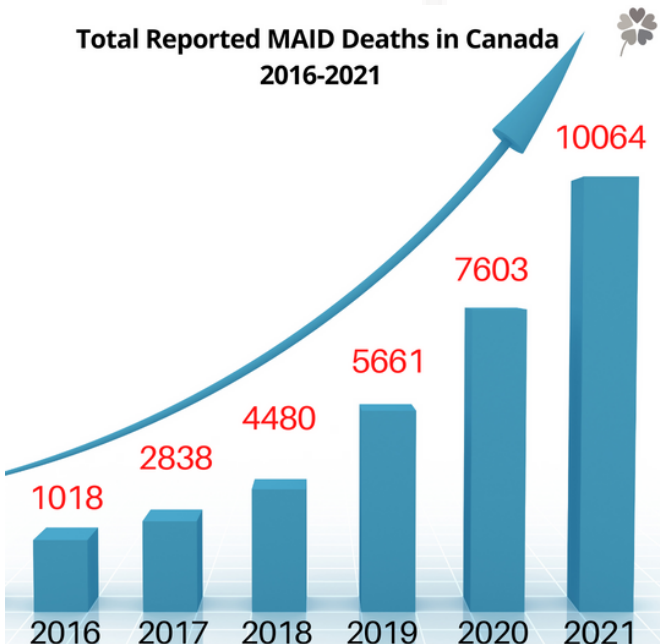
- there were more than 10,000 euthanasia deaths in 2021, an increase of 32.4 % from 2020.
- 3.3% of all Canadian deaths were by euthanasia
- at least 1,700 of the assisted deaths were because of loneliness and isolation.

MAID is already the sixth-leading cause of death in Canada. Next year, Canada will allow those with mental illness to qualify which will certainly add to the death toll significantly.

2016-2021**

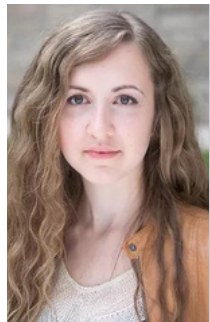


## A Post Roe v. Wade Misconception

In response to the overturning of Roe v. Wade, abortion advocates are instilling fear by spreading the lie that now, women with ectopic pregnancies and miscarriages won't receive the care they need.

In medical terminology, the word abortion is used to describe *all* procedures that would remove an unborn child from the mother's womb, including those after a miscarriage or an ectopic pregnancy. These circumstances are entirely different than an *elective* abortion, which *purposefully* ends the life of an unborn baby.

It's valuable for us to know how abortion promoters are using the medical definition of abortion to create confusion. We need to make it clear that procedures and treatments used in cases of miscarriage and ectopic pregnancy *are not prevented* by any laws restricting abortion post Roe v. Wade.

## March for Life: A Personal Story



Choose Life Niagara (CLN) brought 54 students and chaperones to Ottawa in May for our annual March for Life trip.

At the Youth Conference, the students heard David Scotton share his life story about being adopted, a story that the powerful movie *Lifemark* is based on. 17 year old Rachel was especially moved by David's talk, herself being adopted, and later spoke about the March for Life trip at our CLN dinner held June 4.

"This March hit me emotionally so much. 17 years ago, my birth mother walked away from abortion, being properly educated by people like CLN, that there was another option ...adoption. This provided me a chance at life. This gave me a family who I love very much and would never trade for anything.

To future mothers out there.....you don't have to be afraid of putting a child up for adoption. I can say with 100% certainty, that child will be extremely grateful for your brave decision to give them a chance at life."
